Part 29 thereof, on May 9, 2013 and May 13, 2013, and the Court, following the inquest, having
rendered a decision awarding judgment KRISTINE SEUBERT against Defendants, DR.

WARREN DELUTY, DDS, and SHERYL M. DELUTY for the following:

As against DR. WARREN DELUTY, DDS:

- (a) \$1.781.00 for deprived wages, plus 9.00% prejudgment interest accruing from January 1, 2008, up to and including the date of entry of judgment;
- (b) \$1,435.00 for out-of-pocket expenses for psychological treatment, plus 9.00% prejudgment accruing from October 1, 2008, up to and including the date of entry of judgment;
- (c) \$85,000.00 for compensation for mental anguish, emotional distress, humiliation and embarrassment, plus 9.00% projudgment interest accruing from January 1, 2010, up to and including the date of entry of judgment;
- (d) \$15,000.00 for punitive damages;
- (e) \$150,637.50 for reasonable attorney's fees, plus 9.00% prejudgment interest accruing from May 8, 2013, up to and including the date of entry of judgment;
- (f) \$5,151.87 for disbursements:
- (g) \$700.00 for costs; and

As against DR. WARREN DELUTY, DDS and SHERYL DELUTY:

(a) An order to the Plaintiff setting aside the February 12, 2010 transfer by the quitelaim dead of the Defendants' West Hempstead, New York property, that parcel number 35-92-0247-0.

It is hereby adjudged that Plaintiff; KRISTINE SEUBERT, residing at 8 Kenneth Street, Plainview, New York 11803, recover from and have judgment against. Defendant DR.

WARREN DELUTY, residing at 333Woodfield Road, West Hempstead. New York 11552 in the amount of \$259,705.37, representing \$1,781.00 in wages, \$1.435.00 for out-of-pocket expenses, \$85,000.00 in compensation for mental anguish, emotional distress, humiliation and embarrassment. \$15,000.00 in punitive damages, \$150,637.50 in attorney's fees, \$5,151.87 in disbursements, and \$700.00 in costs, bringing the total to \$259,705.37, plus interest on the \$1,781.00 from January 1, 2008 through the date of entry of this judgment amounting to \$981.77, plus interest on the \$1.435.00 from October 1, 2008 through the date of entry of this judgment amounting to \$692.74, plus interest on the \$85.000.00 from January 1, 2010 through the date of entry of this judgment amounting to \$31,322.50, plus interest on the \$150,637.50 from May 8, 2013 through the date of entry of this judgment amounting to \$9.452.50, altogether totaling \$302,154.88, and that Plaintiff KRISTINE SEUBERT have execution thereof.

It is further adjudged and Ordered that the February 12. 2010 transfer by a quite aim deed of the Defendants' West Hempstead, New York property, parcel number 35-392-0247-0 be set aside.
