If you worked for RUSSELL SPEEDER'S MANAGEMENT COMPANY, LLC, which does business as RUSSELL SPEEDER'S CAR WASH, and/or RUSSELL SPEEDER'S OF BEDFORD HILLS, LLC, and/or RUSSELL SPEEDERS CAR WASH OF SOUTHINGTON LLC, and/or RUSSELL SPEEDER'S CAR WASH OF AVON, LLC, and/or RUSSELL SPEEDER'S CAR WASH OF MANCHESTER, LLC, and/or RUSSELL SPEEDER'S CAR WASH OF WEST HARFORD LLC, and/or RUSSELL SPEEDER'S CAR WASH OF FAIRFIELD, LLC, and/or RUSSELL SPEEDER'S CAR WASH OF SHELTON LLC, and/or MICHAEL SHULLMAN (together as "Defendants"), in New York State, at any time between May 8, 2017, and the present, and/or in the State of Connecticut at any time between July 1, 2021, and the present, *please read this Notice*.

Important: You are NOT being sued. This Notice is NOT a solicitation from a lawyer.

The Court authorized this Notice.

• David Eder Benitez ("Plaintiff") is a former employee of Defendants who worked as a non-managerial customer service associate for Defendants.

- Plaintiff brought this collective action lawsuit against Defendants on behalf of himself and all other current and former employees who worked for any of the Defendants as non-managerial, hourly-paid, cashiers, customer service associates, sales associates, car wash associates, and full-service technicians in New York State at any time between May 8, 2017, and the present and/or in the State of Connecticut at any time between July 1, 2021, and the present. Plaintiff claims, among other things, that he worked in excess of forty hours per week and that Defendants did not pay him overtime pay at the rate of one and one-half times his regular rate of pay for all hours that he worked over forty each week, in violation of the federal Fair Labor Standards Act and the New York Labor Law. Defendants deny any wrongdoing and maintain that they paid all of their employees in accordance with federal and New York law.
- The Court has authorized Plaintiff to send out this Notice. The Court has not yet decided who is right or who is wrong. However, your legal rights may be affected, and you have a choice to make now.

YOUR LEGAL RIGHTS AND OPTIONS IN THIS LAWSUIT

You may then share in any proceeds from a settlement or judgment if those bringing the claims are successful, but you give up any rights to separately sue the Defendants for the same legal claims in this lawsuit.	
DO NOTHING	By doing nothing, you will not be included in this lawsuit at this time.	

1. Why did I get this notice?

You are getting this notice because Defendants' records show that you may have worked for Defendants in New York State between May 8, 2017, and the present, and/or in the State of Connecticut between July 1, 2021, and the present, as a non-managerial employee.

2. What is a collective action and who is involved?

In a collective action lawsuit, one or more persons can bring a lawsuit on behalf of others who have similar claims. The individual who brought this lawsuit is called the Plaintiff. The corporate entities and the individual who are being sued are called the Defendants. One court resolves the issues for everyone who decides to join the case.

3. What is this collective action lawsuit about?

Plaintiff alleges that Defendants' compensation practices violated federal and New York law. Plaintiff claims that he and others who worked for Defendants are entitled to unpaid overtime wages, liquidated damages, attorneys' fees, and costs.

Defendants deny any wrongdoing and/or liability and maintain that they paid all of their employees

in accordance with federal and New York law.

4. What is the purpose and effect of this notice?

This notice is for the sole purpose of determining those persons who wish to be involved in this case.

If you elect to join this proceeding, and Plaintiff successfully obtains a settlement or a judgment, you may be entitled to some portion of the recovery if you qualify under the law. There are no assurances that any recovery will be awarded.

You should be aware that a claim under the Fair Labor Standards Act must be brought within two years of the date that the claim accrues, unless you can prove that your employer's violation was willful, in which case the claim must be brought within three years.

5. How do I join this collective action lawsuit?

To participate in this lawsuit, you need to fill out the enclosed form titled "Consent to Join Lawsuit" and mail it in the enclosed, postage-paid envelope, to Plaintiffs' Counsel, Borrelli & Associates, P.L.L.C. Should the enclosed envelope be lost or misplaced, the Consent to Join Lawsuit form must be sent to:

The signed Consent to Join Lawsuit form must be filed with the court by [60 days from mailing of Notice]. If your signed Consent to Join Lawsuit form is not filed with the Court by [60 days from mailing of Notice], you may not be allowed to participate in this lawsuit.

6. If I choose to join this lawsuit, will I have to participate in any legal proceeding?

Most likely, if you choose to join this lawsuit, you will be required to provide information and answer questions relating to your employment with Defendants. You may be required to testify at a deposition or at a trial, respond to written questions, and/or produce documents relevant to the case. For this reason, if you join the lawsuit, you should preserve all documents relating to your employment with Defendants that are currently in your possession. Plaintiff's attorneys will assist you with these requirements if you elect for them to represent you, as explained in section 10 below.

If you join this lawsuit, you will be bound by any ruling, settlement, or judgment, whether favorable or unfavorable.

7. What happens if I do nothing at all?

You will not be included in this lawsuit, and you will not be affected by any settlement or judgment rendered in this case, whether favorable or unfavorable. The limitations period on your claims

will, however, continue to run.

8. Can I participate in this collective action lawsuit regardless of my immigration status?

Yes. You have a right to participate in this lawsuit regardless of your immigration status.

9. If I join, will there be any impact on my employment?

No. Federal and New York law both prohibit Defendants from discharging or in any other manner retaliating against you because you have joined this case or have in any other way exercised your rights under federal and New York law.

10. Do I have a lawyer in this case?

Plaintiff is represented by Borrelli & Associates, P.L.L.C. If you choose to join this lawsuit, Borrelli & Associates, P.L.L.C. will represent you on a contingency fee basis, meaning that you will not owe any attorneys' fees unless Plaintiff is successful and wins the case or obtains a settlement, in which case the Court will likely determine the amount of attorneys' fees to be paid from any such judgment or settlement.

You do not have to be represented by Borrelli & Associates, P.L.L.C. and may instead hire another attorney of your choosing or represent yourself *pro se* without the assistance of a lawyer. If you intend to retain your own lawyer or to represent yourself, you should indicate this on the Consent to Join Lawsuit form. If you send back your form but do not indicate that you intend to retain your own lawyer or to represent yourself, the Court will assume that you want Borrelli & Associates, P.L.L.C. to represent you.

11. This Notice has been authorized by the Court

This notice and its contents have been authorized by District Judge Victor A. Bolden of the United States District Court for the District of Connecticut, located in New Haven, Connecticut. The Court has not yet ruled on whether Plaintiff's claims or Defendants' defenses have any merit.

Although the Court has approved the sending of this Notice, the Court does not express any opinion on the merits of the lawsuit.
